Applications must be postmarked no later than **Wednesday, October 31, 2018** to be eligible for a 2018 Scholarship award. The CCCEAC Board members will select from scholarship applications for these awards. Award recipients will be announced at the Membership Appreciation Breakfast Seminar on December 4, 2018.

ELIGIBILITY CRITERIA FOR SCHOLARSHIP

- CCCEAC members are eligible. Board members of the CCCEAC are ineligible.
- CCCEAC members may submit nominees for scholarship awards after 90 days of CCCEAC affiliation.
- The program/course submitted must meet the general, personal or career development that will benefit either the individual or organization.
- Academic, vocational skills, and career development courses, extension programs and seminar training may be provided by public or private college, university, vocational institutions and training organizations.

GENERAL INFORMATION

- There is no limit to the number of nominations per applicant.
- Scholarship awards are limited to one, per person, per year.
- Application and proof of current academic registration must be completed and returned within the application period, and in good order to be eligible.
- Scholarship awards will be announced and paid out within 45 days of announcement.
